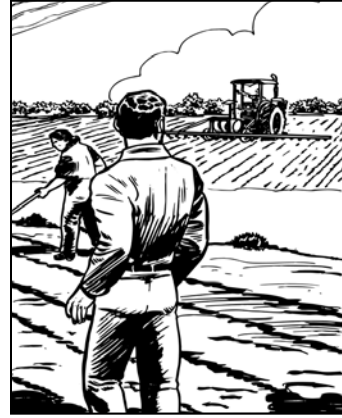


**FREE**  
**Pesticide Safety Training**  
for Agricultural Workers and Pesticide Handlers

**Who Should Attend?**

This training will include important pesticide safety information for **agricultural workers** and **pesticide handlers**. Pesticide handlers are people who mix, load, or apply pesticides as well as those who repair or clean pesticide application equipment. Agricultural workers perform tasks such as pruning, irrigating, weeding, planting, and harvesting in areas where pesticides have been applied in the last 30 days, but do not work directly with pesticides.

*In Arizona, pesticide handlers must receive training on the safe and effective use of pesticides every 3 years and agricultural workers must attend general pesticide safety training every 5 years.*

**SPECIAL NOTE:** This course has been approved for **2 hours of Continuing Education** for Arizona Pesticide Applicator License and Certificate holders who are interested in learning more about the Worker Protection Standard requirements. Please check the "CEU" box on the registration form.

**Training Activities and Topics:**

Discussion, video segments, role play, and case studies will be used to cover the topics required by the Worker Protection Standard (40CFR Part 170) for agricultural worker and pesticide handler training. The training will include such topics as:

- ❖ Routes through which pesticides enter the body
- ❖ Signs and symptoms of common types of pesticide poisoning.
- ❖ Ways to prevent pesticide exposure to people and the environment
- ❖ Warning about taking home pesticides or pesticide containers
- ❖ Important health and safety information listed on pesticide labels
- ❖ Responding to and reporting pesticide exposure and heat-related illness
- ❖ Need for and appropriate use of personal protective equipment
- ❖ Safety requirements of handling, transporting, storing and disposing of pesticides, including general procedures for spill cleanup
