Course Description. Through this workshop, attendees will become qualified to provide Worker Protection Standard pesticide safety training to agricultural workers and pesticide handlers in Arizona.

This course is ideal for growers, supervisors, labor contractors, health care providers, outreach educators and others who will provide safety information to people who handle pesticides or work in areas where pesticides are used.

Workshop Format. This full-day course will be presented in English. Sessions will cover pesticide labels, personal protective equipment, pesticide-related health issues, and training requirements. Participants will receive an instructor's handbook, EPA-approved materials and other useful resources.

A variety of hands-on training techniques and group activities will be used throughout the course to demonstrate ways to extend pesticide safety information to pesticide handlers and agricultural fieldworkers in an interactive and effective manner.
