If entering Showmanship or Judging ONLY, \$2.00 per project (advanced), \$5. Day of show.

Age: Open to all 4-Hers 9-18, by January 1st. Enrolled in Rabbit, Poultry, Pigeon and Cavy

Must indicate Breed class for all poultry entries.

(American, Asiatic, Continental, Bantam, Game Bantam Class Etc.)
