I realize I may withdraw my animal from sale, but must do so by **9:00 P.M. on FRIDAY, SEPTEMBER 16, 2011.**

Only the above designated animal may be sold through the Auction unless another entry is Grand Champion or Reserve Grand Champion, 4-H/FFA Division, Mohave County Fair, of a different class; then both may be sold.

All animals going through the auction ring will pay six percent (6%) auction fee.

Only market animals may be sold. Breeding projects will not be sold in conjunction with the 4-H/FFA Auction.

Only animals receiving a ribbon in a conformation class will be sold in the Auction. The only awards allowed in the sale ring are, conformation awards won on the animal to be sold, **NOT SHOWMANSHIP** awards.

The Mohave County 4-H Leaders' Council, 4-H/FFA Sale Committee, while acting as the selling agent will make all reasonable efforts (including legal action) to collect funds, however, **WILL NOT BE HELD LIABLE FOR UNPAID ACCOUNTS. UPON RECEIPT OF FUNDS FROM BUYER, SELLER'S CHECKS WILL BE DRAFTED WITHIN FIVE WORKING DAYS.**

**I UNDERSTAND** that:

- I must **ATTENDED the Sellers meeting Saturday at 2:00 PM**, failure to attend will result in the writing of an essay and a personal appearance at a Quarterly meeting, before my check will be released.
- Members not showing up to sell their animal OR missing their sale order at the Auction with out the prior approval the Project Director, will have their animals sold to the designated packer at marker price, plus the auction fee.
- Members not properly caring for and delivering their animals to the designated location, when called for shipping, will be Charged a twenty-five dollar (\$25.00) fee.
- **I MUST SUBMIT A PERSONALLY WRITTEN THANK YOU NOTE** to the buyer(s) of my market animal **WITHIN 30 DAYS OF THE AUCTION** and deliver it to the 4-H Office before proceeds from the auction will be released to me.

**The USDA Wholesome Meat Act applies to all animals to be slaughtered at this fair. The act requires the following:**

- a. Antibiotic and sulfonamide have required withdrawal periods.
- b. Drug label directions must be followed.
- c. If drug or chemical residues are found in carcass tissue, or the carcass is condemned, the exhibitor will forfeit all class and sale premium monies, trophies, and special awards.
- d. **ALL animals qualifying for the Auction may be tested, at the discretion of the livestock director, for drug or chemical residue (reasonable efforts will be made to notify Parent or legal guardian and Leader/Advisor of the pending test.) Failure to submit to a drug test will result in the exhibitor forfeiting all class and sale premium monies, trophies, and special awards.**

**ALL Grand and Reserve Grand Champion** Beef, Sheep, Swine and Goat Livestock animals will be sold through the Auction and **WILL** be tested for drug or chemical residue immediately following being designated Grand or Reserve Champion. In addition, one animal of each species will be randomly selected and tested immediately following the show. Exhibitor pays all cost of a test if the results are returned positive.
